Product Description

本品是以葡萄糖浆，食用植物油（部分氢化）为主要原料，添加食品添加剂（酪朊酸钠，单硬脂酸甘油酯，磷酸氢二钾，二氧化硅）后经喷雾干燥等加工工艺制成的粉状制品。

It is a powder product made by the way of spray drying and other technology processing, which mainly contain glucose syrup, edible vegetable oil ( partly hydrogenated ) and add food additives ( sodium caseinate, monostearin, dipotassium phosphate, silicon dioxide ) .
